If you have any questions or concerns regarding the status of your claim, please contact our Accounting Staff on a claim by claim basis.

The WV Racing Commission is offering this report to reduce the uncertainty of claims that have been received and logged in for processing. This, in no way, is an indication that the claims have successfully passed all Accounting and Audit reviews. These steps may still need to be accomplished.

This report is presented as a courtesy and will hopefully provide the Racing Community much more information than was ever available regarding this bonus fund and the current status of claims.
