Notes and Disclaimers

The purposes of this report are as follows:

- * to inform the Racing Community of the Supplemental Purse Award Claims (a.k.a 10-10-10 claims) we have received at the WV Racing Commission offices, and
- * to inform the Racing Community of the date received and the number of days which have lapsed since the race date
- * to inform the Racing Community of the "types of ownership" of the claims submitted (e.g. BREEDER, OWNER, SIRE OWNER)
- * and to provide the Racing Community with an opportunity to refile claims to meet or beat the filing deadlines in place at that time

While WV Code states the time elapsed associated with the claim(s) is/are from the DATE RECEIVED to the DATE PURSE RELEASED, the claims listed are primarily to inform the Racing Community of the claims which have been received at our offices. If you have any questions or concerns regarding the status of your claim, please contact our Accounting Staff on a claim by claim basis.

The WV Racing Commission is offering this report to reduce the uncertainty of claims that have been received and logged in for processing. This, in no way, is an indication that the claims have successfully passed all Accounting and Audit reviews. These steps may still need to be accomplished.

This report is presented as a courtesy and will hopefully provide the Racing Community much more information than was ever available regarding this bonus fund and the current status of claims.

We also hope this helps to reduce last minute calls to the WV Racing Commission offices and which may jeopardize or delay your claims.

It is our goal to update these reports on a weekly basis indicating date last changed for each report, by track.
