On N/A-Hearing Waived, the Board of Judges conducted a hearing regarding allegations set forth in Notice of Hearing issued January 14, 2015. After considering the evidence, the Judges hereby find the following:

Greg Geter did not bring the greyhounds from his kennel that were scheduled to race on Thursday, December 25, 2014 to weigh-in causing seven late scratches.

The Judges conclude that the conduct of Mr. Greg Geter violates section(s) RULE SECTION(S) 35.3.h-TRAINER of the Greyhound Racing Rules, 178 C.S.R. 2. The Judges hereby impose the following penalty: Five hundred dollar (\$500.00) fine. Greyhounds to stand a six (6) day suspension and school before entered into official races. There may be an additional penalty if fine is not paid within seven (7) days of receipt of this notice.

You have the right to appeal this Ruling to the Racing Commission. Your appeal must be received in the Commission Office within 20 days of your receipt of this Ruling and must include a security fee in the amount of \$100.00.

On N/A-Mr, Johnson did not show , the Board of Judges conducted a hearing regarding allegations set forth in Notice of Hearing issued August 2, 2015


After considering the evidence, the Judges hereby find the following:

Mr. Kaleb Johnson falsified his West Virginia Greyhound Racing Occupational Permit Application.



Mr. Geter's Kennel Helper attached the wrong brass identification tag to greyhound "Coach Quizno", (wrong tag # 14-6 and the correct tag was # 7-8) during weigh in at the paddock. The greyhound made it to the lock out kennel with wrong tag. ❏

The Judges conclude that the conduct of Mr. Greg Geter violates section(s) RULE SECTION(S) 35.3.n TRAINER of the Greyhound Racing Rules, 178 C.S.R. 2. The Judges hereby impose the following penalty: One hundred dollar (\$100.00) fine. Greyhounds to stand a six (6) day suspension and school before entered into official races. There may be an additional penalty if fine is not paid within seven (7) days of receipt of this notice.

On several occasions, Mr. Snyder has not properly inspected, maintained and operated the starting box causing several false starts.


The Judges conclude that the conduct of Mr. Joshua Snyder violates section(s) RULE SECTION(S) 16.3-STARTER of the Greyhound Racing Rules, 178 C.S.R. 2. The Judges hereby impose the following penalty: Mr. Snyder's Occupational Permit #30620 (Starter) is suspended indefinitely effective Sunday, October 25, 2015 at his normal beginning work hour. Mr. Snyder may apply for other positions.
