The official sample (Sample #121951-) taken on March 1, 2015 was reported by Truesdail, to contain Clenbuterol, a Class 3 drug, in excess of the threshold allowed by Table 178-1 F of the Thoroughbred Racing Rule, 178 CSR 1. The same sample was also reported by Truesdail to contain Mepivacaine, a Class 2 drug, in excess of the threshold allowed by Table 178-1 F of the Thoroughbred Racing Rule, 178 CSR 1. The sample was taken from "Kinda Kinda" which ran in the 5th race at Mountaineer Racetrack on March 1, 2015, finishing 1st. The horse is owned by Harold Bragg and is Trained by Jamie Stokes.

The official sample (Sample #121986) taken on March 4, 2015 was reported by Truesdail, to contain Clenbuterol, a Class 3 drug, in excess of the threshold allowed by Table 178-1 F of the Thoroughbred Racing Rule, 178 CSR 1. The same sample was also reported by Truesdail to contain Mepivacaine, a Class 2 drug, in excess of the threshold allowed by Table 178-1 F of the Thoroughbred Racing Rule, 178 CSR 1. The sample was taken from "Bishamon" which ran in the 4th race at Mountaineer Racetrack on March 4, 2015, finishing 1st. The horse is owned by My Purple Haze Stables (Wanda Polissen) and Trained by Jamie Stokes.

Jamie Stokes did not elect to conduct split sample testing on the samples and waived her right to a hearing before the Stewards in these matters.

The Stewards conclude that Jamie Stokes has violated the Thoroughbred Racing Rule, 178 W. Va. C.S.R. 1, §§ 26.2., 49.4.a., 49.4.a.2., 51.1.a. and Table 178-1 F. Therefore, Jamie Stokes' permit is subject to discipline by the Stewards pursuant to 178 W. Va. C.S.R. 1, §§ 8.5., 24.11.e., and 24.11.o. These four medication/prohibited substance violations, all occurring at or about the same time and prior to the delivery of official notice by the Stewards, shall be treated as two separate violations, one for each substance.

Both Clenbuterol and Mepivacaine are drugs with a Category B penalty designation. The Penalty Guidelines set forth in Table 178-1 E of the Thoroughbred Racing Rule provide a fifteen days minimum/sixty days maximum suspension and \$500.00 minimum/\$1,000.00 maximum fine for a first offense Category B violation. The Penalty Guidelines also provide a penalty of thirty days minimum/180 days maximum suspension and \$1,000.00 minimum/\$2,500.00 maximum fine for a second offense Category B violation. The Penalty Guidelines also provide for disqualification of the horses in question and loss of purse. However, pursuant to 178 W. Va. C.S.R. 1, § 49.1., the Stewards determine the appropriate penalty on a case by case basis and may consider both mitigating and aggravating factors.

In reviewing and considering the appropriate penalty in this case, the Stewards considered the past medication/prohibited substances record of Jamie Stokes: Ms. Stokes has had no previous Medication violations.

In reviewing and considering the appropriate penalty in this case, the Stewards considered the potential of Clenbuterol and Mepivacaine to influence a horse's racing performance. Clenbuterol is a Class 3 drug under 178 W. Va. C.S.R. 1, Table D. Class 3 drugs "all have the potential of affecting the performance of a racehorse." 178 W. Va.

C.S.R. 1 49.2.c. In addition, Mepivacaine is a Class 2 drug under 178 W. Va. C.S.R. 1, Table D. Class 2 drugs "have a high potential for affecting the outcome of a race." Accordingly, this is an aggravating factor.

In reviewing and considering the appropriate penalty in this case, the Stewards considered the legal availability of the drug, Clenbuterol. Clenbuterol and Mepivacaine are legally available. However, the fact that drugs which have the potential to alter a horse's performance are legally available is not entitled to weight as a mitigating factor. Therefore, the fact that Clenbuterol and Mepivacaine are legally available is a neutral factor.

In reviewing and considering the appropriate penalty in this case, the Stewards considered whether Jamie Stokes knew of the administration of the drug or intentionally administered the drug; the steps taken by her to safeguard the horse(s); and, the probability of inadvertent exposure or environmental contamination.

In reviewing and considering the appropriate penalty in this case, the Stewards considered the purses of the races and whether there were any suspicious betting patterns. The Stewards found no Irregularities.

Based upon the foregoing, the Stewards hereby **SUSPEND** Jamie Stokes' occupational permits for a total of 45 days effective Sunday March 29, 2015 through and including Tuesday May 12, 2015. In addition, the Stewards hereby **FINE** Jamie Stokes in the total amount of \$1,500.00. This fine shall be paid within seven days of the issuance of this ruling. The Stewards conclude that this suspension and fine is warranted due to the particular facts of this case.

It is further **ORDERED** that during the term of his permit suspension, Jamie Stokes shall be **EXCLUDED** from association grounds under the jurisdiction of the West Virginia Racing Commission.

In addition, the Stewards do hereby **ORDER** that "Kinda Kinda" be disqualified of all Purse Monies and the purse to be re-distributed as follows, 1st-Take the Train 2nd-Total Bliss 3rd-Princess Janelle 4th-Sassy Miss Cathy 5th-Sunny Sights.


